1A – US Government Regulations and Financial Aid for CBE Programs *Deb Bushway,* Consultant, Lumina Foundation

An overview of the US government regulations with respect to CBE programs, Title IV, and implications for program design and financial aid presented by Deb Bushway, who is deeply involved in the Competency Based Education movement, including the launch of Capella University's CBE direct assessment program, the growth of C-BEN (the Competency-Based Education Network) and service as Senior Advisor to the Undersecretary at the US Department of Education regarding educational innovation. She recently testified in front of the Senate HELP committee on higher education innovation and federal policy.

1B – Managing Change for Faculty

One of the most critical aspects of offering a CBTE program is securing the support and participation of faculty. Effective management of this change requires an understanding of what drives them, the unique characteristics of their role, and the effects of CBTE on both. This session offers suggestions on how to work with your faculty to embrace and deliver a CBTE program, and examines issues such as faculty load, using adjuncts, generalist versus specialist role, and transitioning from classroom to context-based delivery. It draws on the experience and input of Northwest Baptist Seminary faculty, who met earlier this year to reflect on what concerned them about moving to CBTE and what convinced them, share ongoing concerns, and offer advice to other schools considering a similar change.

Moving toward CBTE is not something a single visionary administrator can do alone. Having interviewed stakeholders of schools where competency-based theological education has been adopted, they'll share what they've learned — who were the advocates, and who were the roadblocks — and offer some tips on moving forward collaboratively.
